RESOLUTION OF NECESSITY

RESOLUTION REQUESTING CERTIFICATION FROM COUNTY AUDITOR
PURSUANT TO OHIO REVISED CODE SECTION 5705.0
(Dollar amount of revenue generated by specified number of mills)

WHEREAS, the Council of The Village of Warsaw of Village of Warsaw, Coshocton County, Ohio, determines that it is necessary to levy a tax outside the ten-mill limitation, and

WHEREAS, before seeking to have a levy approved by the electors of Village of Warsaw, the Village must seek the certification of the Coshocton County Auditor in compliance with Section 5705.03 of the Ohio Revised Code, submitted for the General election held on November 5, 2024.

THEREFORE, BE IT RESOLVED, by the Council of The Village of Warsaw of Village of Warsaw Coshocton County, Ohio, that the Coshocton County Auditor is hereby requested to certify to the Council of The Village of Warsaw:

- 1. The total current tax valuation of entire territory of The Village of Warsaw \$ 9,392,300, and
2. The number of mills for each \$1 of taxable value that is required to generate \$ 18,973 of revenue.

BE IT FURTHER RESOLVED that the purpose of the tax is Current Expenses

And is for a period of 5 years, being first levied in year 2025, first collected in calendar year 2026 and appearing on the tax list for the years specified: 2025,2026,2027,2028,2029

Such tax is authorized to be submitted to a vote of the electors of the entire territory of The Village of Warsaw pursuant to Section 5705.19(A) of the Ohio Revised Code, and shall be levied on the residents of the

BE IT FURTHER RESOLVED that the Coshocton County Auditor is requested to issue the certification within ten days after receiving this Resolution.
