Mike Baker gave the Village council the update on City of Coshocton Waterline project and the Neighborhood Revitalization Grant.

The Village of Warsaw did not receive the CDBG Neighborhood Revolutionization Grant. The Village didn't have public here for the hearings and little input on the surveys turned in to the Village. All projects are judged on scores and we didn't score very well.

The City of Coshocton didn't receive the \$750,000 additional funding towards the Water Line Project from the CDBG for Residential Public Infrastructure Project. They still have \$10.5 million going toward the project and will be bidding out next March or April for the project.

Josh Young has been in contact with Bob Snavely, Energy Consultant with Palmer Energy. He will be getting rates for Electric Prices and Gas Aggregate.
