**A RESOLUTION FOR CERTIFICATION OF MILLAGE FOR RENEWAL OF
TAX LEVY**

Village of Warsaw meet in regular session on March 15, 2023 with the following members present:

Ed Kent, , Brenda Davis, Jesse Fischer, Corey Fischer, Josh Young, Jerry Funk
Mayor – Ron Davis and Fiscal Officer – Tammy L Pope

Ed Kent moved the adoption of the following Resolution:

In accordance with **Section 5705.19 (A) and 5705.03** of the Ohio Revised Code, for current expenses of the subdivision, except the total levy for current expense of a detention facility distractor district organized under Section 2151.65 of the Revised Code shall not exceed tow mills and that the levy for current expenses of a combined district organized under sections 2151.65 and 2152.4 of the Ohio Revised Code shall not exceed for mills;

the Village of Warsaw requests certification from the County Auditor of the total current tax valuation of the Village. The **renewal** is for Current Expense at the rate of 2.0 Mills for each dollar of valuation, which amounts to two tenths for each one hundred dollars of valuation, for a 5-year renewal.

The Village intends to submit the following levies for passage in the November 7, 2023 election for the tax year 2023 and collected in 2024 to be voted on every 5 years.

The territory where the ballot measure is to be submitted will be the entire territory of the Village of Warsaw in Coshocton County.

The entire territory of the Village will be where the tax is to be levied.
